# The Controller provides the Data Subject with the following information pursuant to Article 13 of the EU Regulation:

The legal basis for the processing of personal data obtained from the Applicant and specified in this application is Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data. The Controller stores these data for the duration of the purpose of processing and for the duration of the storage period of the filing record, which is five years in accordance with the Controller's Filing Regulations. The Purpose of the Processing of this Data is to Register and Handle the Data Subject's Request to Exercise His/Her Rights in accordance with applicable legislation. The Controller has, in accordance with the EU Regulation, a designated responsible person in charge of the supervision of personal data protection (hereinafter referred to as the "responsible person").

**The recipients** of personal data in accordance with this purpose are the <u>Controller</u>, the <u>Data Subject</u> or the <u>Office</u> for Personal Data Protection of the Slovak Republic, toward which the Controller has a notification obligation and the <u>recipients</u> to whom the Controller is obliged, <u>pursuant to Article 19 of the EU Regulation</u>, to notify the correction/deletion of personal data or the restriction of the processing of personal data.

The Data Subject has the right to provide information, the right to access personal data, the right to correction and the right to submit a proposal to initiate proceedings pursuant to Section 100 of Act No. 18/2018 Coll. on the Protection of Personal Data.
